## Approval of Offer for Sale:

The chairman apprised the board about the latest amendment in Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) (Amendment) Regulations, 2025 w.e.f. 08.03.2025:

- (i). the size of offer for sale by selling shareholders shall not exceed twenty per cent of the total issue size;
- (ii). the shares being offered for sale by selling shareholders shall not exceed fifty per cent of such selling shareholders' pre-issue shareholding on a fully diluted basis;

In connection with the said amendment the Board has revised consent and resolution from AUMIT CAPITAL ADVISORS LIMITED for the Offer for Sale of their Equity Shares, subject to the approvals from relevant regulatory authorities on the terms and conditions and Price mutually agreed between the Company and them.
